## APPLICATION FOR MEMBERSHIP & KENNEL AFFIX

### What is an Affix?

An Affix is a Kennel Name which is an exclusive word that is associated with you and your dogs. Known as your 'breeder signature', a Kennel Name will set your puppies aside from those of anyone else.

You can include your Kennel Name within the names of your puppies at the point of registration as well as add to an existing name of a dog in your current registered ownership.

### NOTES FOR GUIDANCE IN THE APPLICATION OF MEMBERSHIP AND GRANTING OF KENNEL NAME

1. The name may be a unique word created by the applicant.
2. The name may contain a maximum of two words and a maximum of 20 total characters and spaces – A minimum of 4 letters is allowed.
3. The name may not include a breed or reference to a breed or colour specific to a breed
4. Ineligible words would include, but are not limited to, conflict either phonetically or in spelling with: the name of a breed, Corporations or Trade names, names of famous and universally recognized persons, living or dead, or words commonly used
5. A kennel name may not contain any derogatory or discriminatory words. The Kennel Name will be used as the first word in the name of a dog bred by the Registered owner of the Kennel Name. Where a dog has been acquired by transfer of Prefix 20, Common Name 20, Suffix 20 = total 60.
6. The name of a dog may only be changed after initial registration by the addition of the transferee's registered Kennel Name at transfer of ownership. In order for a Kennel name to be added the registered Kennel name of the new owner, the single
7. Every affix provisionally accepted shall be published on [www.ekasa.co.za](http://www.ekasa.co.za) and any objections thereto shall be lodged with the Association within thirty (30) days of publication.

Should any objections to the use of such "provisional affix" be received, and the objection be upheld, all Certificates issued are subject to cancellation. Application for another name would need to be submitted thereafter.
